

## ACTION Item 7 CHAIR AND CO-CHAIR SEATS RENEWALS

Chairperson Dwight Foltz and Co-Chair Bill Wathen were submitted to remain seated as Chair and Co-Chair of the Children and Families Commission. \***Comment:** Commissioner Aulabaugh- bylaws say that seat renewals are in July, and has conflict with way it was presented on agenda because it is stated as if it was something that was predetermined with Commissioner's Foltz and Wathen. She feels there should have been nominations from the floor, but does not have an issue with keeping the Chair and Co-Chair as is. States it is against parliamentary procedure to not have consulted with Commission before stating so in the agenda. Commissioner's Wathen and Foltz responded respectfully that they did not have prior knowledge of this temporary request. Executive Director informs Commission that this suggestion was presented for submission it is still with in protocol to present to the commission moving forward and either approved or not approved during the meeting. Commissioner Hahn asked when terms expired, or if they have expired. ED explained that Chair Foltz' term had but Commissioner Wathen's had not. Commissioner Aulabaugh clarified that the question was "when did the term of services as an officer expire, and that it expired last July". ED explained that they were unable to and decided best to do it at the end of the year due to sporadic meetings, business, and communications during the Pandemic. Chair Foltz also offered that it was likely due to the BOS changing the appointed supervisor more than once in the last few years, and the Executive Director unknowing of who's support First 5 was going to receive. This uncertain knowledge of current business and restructuring of current services was possibly seen as a potential interruption for First 5 Glenn if new appointments were to be made. Commissioner Aulabaugh recommended that the Commission review their Bylaws for clarification and possible updates. ED suggested and Commission agreed to leaving things as they are for now due to Commissioner Hahn's first announcement of resignation and the amount of business needing to be presented, discussed, and voted on prior to July 1st. Commissioner Hahn made first motion for current Chair and Co-chair to remain in their seats, with their terms ending on July 1, giving time to review and make changes to the Bylaw moving the elections to January.
