- ❖ Patricia Loera, Executive Director delivered information of the 20th year Anniversary of First 5 California. She reported on upcoming Advocacy Days that will be celebrated throughout the year beginning May 1, 2018 in Sacramento with all county Commissioners, Agency representatives, community members invited to attend at the capitol. - Kelsey Adkins-LMFT, attended the First 5 Association Meeting in January in place of Executive Director who was out with the flu. Ms. Adkins reported out that Advocacy Day is scheduled for May

2nd, 2018 at the Capitol main lawn in Sacramento. Discussions were held regarding all outreach materials to be displayed and distributed throughout all 58 counties. Additional events will be taking place before the end of the program year 2017-18. More details on these events to come.

- Rosa Esparza, First 5 Glenn County Program/ Data Coordinator, reported out on the current data of enrollments of parents and children in the Little Learners Programs as well as the Nurturing Parenting Programs. Current enrollments for October 2017 were 10 families of children and parents. Referrals were received from the following agencies: Health and Human Services, Hamilton Unified Elementary School, Mill Street Elementary School, and self-referred families with dental health needs. These referrals were entered into our First 5 Glenn's Online Data Master (ODM), data recording program.
- ❖ Nanci Orozco, First 5 AmeriCorps Supervisor and Event Coordinator Assistant, introduced the 2017-18 AmeriCorps members: Maddison Heffley, Evan Orozco, Rene Cabral, and Sean Loera. First 5 Glenn currently has four AmeriCorps members serving in Glenn County. These members are providing services at the following locations: Hamilton Unified Elementary School, Walden, Murdock and Mill Street Elementary Schools. In these locations they provide support for children in TK/K classrooms that were identified in the spring 2017 Devereux Early Childhood Assessment's (DECA) and upon referrals. The DECA Assessments are implemented annually by trained and certified First 5 Staff to identify the incoming TK/K students who will need support in the classrooms with developing Social/Emotional, self- regulation and initiative skills for school success.

These **AmeriCorps** members also facilitate all **Little Learner Playgroups**, **Nurturing Family Events**, and **Nurturing Parent Engagement Services**, **Support Groups**.

- ❖ Bobby Sue Althaus, BSW, the First 5 Glenn County resident Social Worker and Nurturing Parenting Program Facilitator, presented an update on the current status of the Nurturing Parenting Program. She went on to discuss the importance of the program through sharing a current touching success story of a family in services. She then shared her future plans and goals regarding the Nurturing Parenting program and its potential for parents and community.
- ❖ Patricia Loera, Executive Director, provided the Commission with the Prop. 10 monthly disbursements and Small County Augmentation schedule.

Commission held discussion regarding declining revenues at the state level of the Prop. 10 Tobacco Tax. This decline will reflect in First 5 Glenn County's long time services in the Transitional Kindergarten and Traditional Kindergarten classrooms. This has been a very successful program having the assigned, certified AmeriCorps in the classrooms facilitating DECA (Deverex Early Childhood Assessments) and supporting children as needed.

It was decided that DECAs would continue within the Little Learners

Program at the Nurturing Nest. This service will wind down in the schools and First 5 will embark on the state wide interest of the ACES (Adverse Childhood Experiences Survey). This survey will have a centralized database. First 5's and schools are negotiating moving forward with this ACES as being a united front on customizing children's needs for healthy social and emotional needs and supporting them in environments and with teachers that know their best interests in learning. Staff will continue trainings in this field and return to Commission Meetings with follow up reports.

Further discussion was held in creating ideas regarding stretching Funding and service delivery. Internal discussions will include the

The renewal of the First 5 Glenn County Strategic Plan was presented and the Commission and visiting community members went through the plan and made adjustments and fine-tuned the plans for First 5 Glenn services for children Birth to Five and their families.
